SUMMARY: This position is primarily responsible for performing duties such as welding, drilling, tapping, and/or running the saw to cut steel by performing the following duties

DUTIES AND RESPONSIBILITIES:

Core duties and responsibilities include the following. Other duties may be assigned.

- Fabricate and assemble metal structures and equipment through the use of welders, cutters, shapers and measuring tools.
- Read and interpret diagrams, sketches and blueprints to determine operations, required materials and timeframes for projects.
- Operate and maintain welding equipment.
- Pushes/pulls carts to stack steel on and mover from one station to another.
- Operates a forklift

ATTENDANCE:

Must be punctual and timely in meeting all requirements of performance, including, but not limited to, attendance standards and work deadlines; beginning and ending assignments on time; and scheduled work breaks; where applicable.

QUALIFICATIONS:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. COMPETENCIES:
